**With this contract, the Buyer agrees to buy the Ragdoll Cat listed above  
with the following conditions:**

- 1) This cat is a family member, it needs all attention to live a peaceful life. The cat will be kept un-caged, unless absolutely necessary for the cat's safety or health and only for a short time.
- 2) The buyer is obligated to provide proper veterinarian care of a licensed veterinarian if there is such a need. All veterinary recommendations will be respected.
- 3) Buyer commits to keep in touch with Ritterkatz Ragdolls Cattery during the entire life of the cat.

- 4) Under no circumstances will this cat be sold, leased, or given away to any pet store, research laboratory, breeding mill, or similar facility.
- 5) If the cat can't stay in the cattery any longer, the Buyer must contact the Seller.
- 6) Ritterkatz Ragdolls cats are not to be declawed at any time, doing so will void the contract.
- 7) Buyer must inform Ritterkatz Ragdolls in the case of death occurs.
- 8) This cat is FIV/FELV negative. The cat has 2 vaccinations (against Rhino-Tracheitis (Herpes Virus), Panleukopenia and CaliciVirus,), Rabies Vaccination, and has been dewormed.
- 9) The parents of this cat and the cat are HCM N/N, PKD N/N.
- 10) The buyer is responsible for a veterinarian health checkup within 7 days of receiving the cat to confirm that the cat is in good health. The FELV vaccine is not recommended due to some Ragdolls having a bad reaction to this vaccine.
- 11) In the event of a replacement, the kitten needs to be shipped. Shipping costs are the Buyer's responsibility.
- 12) The cat will be bred exclusively with Ragdolls of the Buyer (registered to one or more associations, owning a regular pedigree for Breeding).
- 13) The name of the cat is Ritterkatz \_\_\_\_\_ and the name must be written entirely in pedigrees, websites, blogs, Facebook. The prefix "Ritterkatz" must never be omitted.
- 14) The Buyer must be registered in a regular feline association and must own a regular prefix, if that is not possible yet Buyer has to request a prefix contextually with the first litter of this cat. Every kitten out from this cat must be registered.
- 15) All pet kittens out from this cat must be neutered/spayed before leaving Buyers cattery.
- 16) This cat must be mated only with Ragdolls tested N/N for HCM. This cat can't be mated with Ragdolls HCM N/P or P/P. This cat must be mated with Ragdolls tested for FIV and FeLV negative.
- 17) The cat must be neutered/spayed before arriving at a new loving Pet Home, it can't be sold intact (not spayed/neutered) to other catteries or persons.
- 18) This cat is sold as a Breeder quality, but the Seller can't guarantee the real exposition career. This cat has a sweet personality, but the Seller cannot take responsibility for the behavioral changes of the cat with the new owner and their new environment.
- 19) The buyer must pay the entire price of the cat before the cat can be transferred to the Buyers Cattery.
- 20) Seller will not be responsible for any veterinarian expenses incurred while the cat is in the Buyer's care.
- 21) The transfer will be provided as soon as it's issued by The International Cat Association (TICA).
